Computer quotes for Clerk and Treasurer Supervisor Johnson got three quotes-Shift Tech for \$779 each.

Supervisor Waytashek made a motion to accept the Digital Magic quote, second by Supervisor Wollak, motion carried.

#### **Annual Newsletter**

For 2019 the printing cost was about \$2,600, there are 1,200 homes to mail to, Supervisor Johnson would like to go to digital only, but there are senior citizens who like the paper version. Supervisor Wollak would also like to go digital only to reduce costs. There are some required items in the newsletter but the number of pages can be reduced. Supervisors Waytashek and Wollak will draft their letters and send them to Clerk Davis, who will compile them as they are received. Supervisor Wollak suggested a Special Meeting to make sure the Tax Capacity numbers are accurate, no action taken.

# 2020 Budget Draft/Road Construction Budget Draft

The Annual Audit and Budget meeting is schedule for January 21<sup>st</sup>, 2020, at 5 PM. Supervisor Johnson spend three hours and did a nine page budget using preliminary year end numbers and she asked the other Supervisors to review the budget she prepared.

#### Wacosa Contract

This was up for renewal, the price stayed the same as last year, Supervisor Waytashek made a motion to approve, second by Supervisor Wollak, motion carried.

#### Other agenda items

SCORE Grants - There is one available to recycle fluorescent bulbs which Supervisor Wollak will follow up on, Supervisor Johnson will prepare the Cleanup Day Grant.

Bobcat Dealer on Sues Road – If no action is taken in one week the County will take over the cleanup process.

Tri-County Humane Society – Supervisor Waytashek would like to add a dollar amount to the Budget, it would be for \$750 and it can't be a donation, it must be a contract. Clerk Davis will get a copy of the last contract and forward to Supervisor Waytashek.
