Supervisor Waytashek made a motion to move money from Town Hall Building to Road & Bridge Fund, seconded by Supervisor Wollak, motion carried.

Approve list of Bills & Claims & Payroll

Supervisor Wollak made a motion to approve bills and payroll, second by Supervisor Waytashek second, motion carried.

Clerk Davis is on medical leave. Past clerk Nicole Burski will take care of bills and claims. Deputy Clerk Sandra Saldana will take care of meeting minutes and election.

105th Street Quite Crossing Report

Nick Anderson, Bogart & Pederson, gave an update. He is anticipating advertising for bids will go out after next board meeting with bid opening at April 2020 board meeting.

MS4 – 2019 Annual Report

- a. Hanson Property. Supervisor Waytashek will visit the site this Saturday as there has been a complaint on earth moving activity.
- b. MPCA Grant Opportunity Consideration. Supervisor Johnson relayed to Deputy Clerk Saldana that she would be willing to write the grant request. Item was tabled until March meeting when all supervisors are present.

Supervisor Waytashek stated that he will bring all the MS4 files/books to the town hall when he has completed the annual report.

Newsletter Report

Budget/Levy Report

Boundary Commission

Julie Fandal requested the Resolution 2020-3 be read. Supervisor Wollak read the resolution. Supervisor Waytashek made a motion to approve the resolution, seconded by Supervisor Wollak, motion carried.

Benton County Dept of Development

- a. Derrick Nelson. Neither Supervisor Wollak or Waytashek had any issues with this request to add a storage structure
- b. RHL Todd J. Payne. Supervisors Wollak and Waytashek and Wollak both stated that this was too close according to the county requirements.

c. Steve & Rose Johnson. Steve Johnson spoke requesting approval of the roof connecting the two buildings. Steve Johnson will continue to work with Benton County Department of Development. Supervisor Wollak stated he did not have an opinion on this issue as there is more information needed by the Department of Development. Supervisor Waytashek did not comment.

Deputy Clerk Saldana stated that Supervisor Johnson sent an email asking for this to be taken care of.

Citizens Input

Paul Wippler as about item #12 on the budget. He stated there is no line for fines. Paul stated since we had an MS4 fine in 2019 that there should be a line item for fines. Paul also asked why Mark Macnamara from Benton County Department of Development has not been contacted regarding the activity on the Hanson property.
