Kevin proposed splitting the project or pushing the West Lake Road project to 2024 altogether and looking at other roads in need of construction/repair (e.g., Sues Road, Ferry Point).

The Minnesota Association of Township Insurance Trust is the agent for our Consolidated Liability Coverage. There has been a rate increase of 9.8% for 2023. Total premium due on March 15, 2023, is \$3,589.00.
