## Watab Township Supervisors' Meeting December 4, 2018

#### REGULAR MONTHLY MEETING MINUTES

A regular monthly Watab Township supervisors' meeting was called to order by Chairman Waytashek at seven o'clock p.m. in the Watab Township Hall

A motion was made by Supervisor Gondeck, seconded by Chairman Waytashek, and carried approving payment of monthly bills and withdrawal of funds for the same in the amount of \$39,851.09 in claims and \$3,596.25 for payroll.

Steve Wollak commented on the use of pick-up snow plows used by Marson Contractors to remove snow and ice from Township roads, and Paul Wippler raised a question about the increase in Township taxes when the school district, state, and county taxes all decreased. Supervisor Gondeck will explore the situation.
