Watab Township Supervisors' Meeting January 2, 2019

REGULAR MONTHLY MEETING MINUTES

A regular monthly Watab Township supervisors' meeting was called to order by Chairman Waytashek at 7:15 p.m. in the Watab Township Hall. The meeting followed special/closed meetings which began at 6:10 p.m.

Those present offered allegiance to the flag of the United States of America.

ROLL CALL

Board supervisors present were Craig Gondeck, Julie Johnson, and Todd Waytashek. Others present included Clerk Jon Hull, Treasurer Deborah O'Keefe, Natasha Barber from the Sauk Rapids Herald, and guests Mike Burton, Buzz Cripe, Mary Beth Cripe, Kate Engebritson, Terry Hull, Jerry Kostreba, Brad McIntosh, John Olson, Jack Polcher, Kevin Reiter, Sandra Saldana, Jessica Storkamp, Ray Thompson, Paul Wippler, Robin Wollak, and Steve Wollak.

APPROVAL OF AGENDA

A motion was made by Supervisor Gondeck, seconded by Supervisor Johnson, and carried approving the proposed meeting agenda with the addition of a Benton County assessor report, Fire District I cost analysis, and a Rockwood Estates Wastewater Treatment Facility status report.

APPROVAL OF MINUTES

A motion was made by Supervisor Gondeck, seconded by Supervisor Waytashek, (Supervisor Johnson was not in attendance at the December meeting) and carried approving minutes of December 4, 2018. Meeting participant Mike Burton expressed dissatisfaction with the minutes that did not describe his issues with the manner in which the proposed 2019-2020 agreement between the City of Rice and Watab Township for "Firefighting, Emergency Medical Services, and Rescue" was processed.

A motion was made by Supervisor Johnson, seconded by Supervisor Gondeck, and carried to expunge the name of "John Polcher" from the approved November 13, 2018 Watab supervisors' meeting minutes.

TREASURER'S REPORTS

A motion was made by Supervisor Johnson, seconded by Supervisor Gondeck, and carried accepting the Treasurer's cash control report indicating a balance of \$631,471.51 and the monthly receipts report. Supervisor Johnson requested a monthly budget report.

A motion was made by Supervisor Gondeck, seconded by Supervisor Johnson and carried authorizing payment of monthly bills/payroll and withdrawal of funds in the amount of \$23,486.00.

CITIZENS' INPUT

Ray Thompson – road improvement costs Brad McIntosh – critical of manner in which public input is conducted Kevin Rieter – indicates the challenge between public input with the Board and the ability to conduct Township business Lloyd Erdmann – supportive of Board's actions in regard to Rice fire contract Mike Burton – opposes Lloyd Erdmann's opinion and leaves the meeting

ACTION ITEMS

Scheduling of Meetings

A motion was made by Chairman Waytashek, seconded by Supervisor Gondeck, and carried scheduling the annual budget meeting and the annual Board of audit meeting for nine 'clock a.m. January 15, 2018, in the Watab Township Hall located at 660 NW 75th Street in Sauk Rapids, Minnesota.

A motion was made by Supervisor Gondeck, seconded by Chairman Waytashek, and carried scheduling the annual Board of Appeal and Equalization hearing for Monday, April 1, 2019, beginning at 2:30 p.m.

Consideration of Tree/Branch Removal Quotes

A motion was made by Supervisor Gondeck, seconded by Supervisor Johnson, and carried accepting the quote of \$450 received from Rice Contracting and Development Services for tree trimming on Sucker Creek Road and Ideal Road. Quotes received for removal of trees on Ideal Road were tabled pending receipt of further information.

2019 WACOSA Contract

A motion was made by Supervisor Gondeck, seconded by Supervisor Johnson, and carried approving the 2019 WACOSA and Watab Township contract for townhall cleaning services at \$62.92 per hour for four workers and one supervisor the second and last Friday of each month. There was some discussion among meeting partcipants regarding the charging of township hall guests for hall cleaning costs.

Scheduling of Proposed Road Improvements Meeting

A motion was made by Chairman Waytashek, seconded by Supervisor Gondeck, and carried scheduling the following meeting (including Nick Anderson from Bogart, Pederson, and Associates) for Tuesday, January 22, 2019:

Meeting participants voiced their concerns regarding cost and substandard road widths.

Adoption of Resolution Designating Annual Polling Place

A motion was made by Supervisor Gondeck, seconded by Supervisor Johnson, and carried adopting the following resolution:

WHEREAS, it is important that citizens exercise their rights to vote at their local polling place;

- WHEREAS, Minnesota Statutes 204B.16 requires the Town board to designate its local polling place for elections annually;
- NOW, THEREFORE, BE IT RESOLVED, that the Town board of Watab Township, Benton County, Minnesota does hereby designate the Town Hall at 660 NW 75th Street in Sauk Rapids, Minnesota, in Benton County, as its polling place for 2019.
- **BE IT FINALLY RESOLVED**, that the Township notify residents of this designation by following the requirements of Minnesota Statutes 205.16.

DISCUSSION TOPICS

Annual Newsletter

Supervisor Gondeck reported that there is little or no interest among vendors to subsidize costs of the annual Township newsletter. Supervisors continue their work on newsletter articles.

Review of 85th Street and 95th Street Improvement Costs

Chairman Waytashek provided preliminary costs of both these projects. However, it became clear there was additional information to be obtained before the total costs were finalized. One of the questions verbalized was cost per mile. The report was tabled pending further investigation.

REPORTS TO AND FROM BOARD

Report from Assessor

Supervisor Gondeck reported on information he received from the Benton County assessor's office regarding valuation proceedings. Paul Wippler responded that was not the information he requested. The Board will follow up on his request about the increase in taxes at the Township level.

Fire District I Report

Supervisor Johnson distributed a spread sheet report developed with the assistance of Treasurer O'Keefe. This led to questions and discussion by Lloyd Erdmann, Ray Thompson, and Steve Wollak. More information will be forthcoming before any changes to Township procedures are considered.

Rockwood Estates Wastewater Treatment Facility

Chairman Waytashek reported the State of Minnesota has approved the facility's plan for the next ten years.
