Motion was made by Supervisor Little to approve request for CUP; Supervisor Wollak seconded; motion carried.

• Tom Friedrich is putting in a natural wetland to increase duck population east on Little Rock Road. Has already been approved.

 John Polcher—permission to construct storage shed. Must fill out Land Disturbance Permit.

Motion was made by Supervisor Little to approve construction of shed; Supervisor Wollak seconded; motion carried.
