a. Paver Program/Road Results

Overall rating of roads is 55—low in comparison to other townships. 20%--excellent 29%--good 40%--poor

b. Road Funding

If roads are maintained as currently budgeted, road ratings would drop significantly. Several budgeting options were presented.

Tax Rating by County:

- 2013: 6<sup>th</sup> highest taxed in state
- 2014: 7<sup>th</sup> highest taxed in state
- 13<sup>th</sup> highest taxed in state 2017:
- 2020: 23<sup>rd</sup> highest taxed in state
  - Ag values are set to increase next year.
  - Home values have increased.
  - Sales tax implemented in 2019—projected 1.9 million; have taken in 2.55 million. •
  - Gas tax down 8-11%. •
