- **WHEREAS**, the Town Board of Watab Benton County, state of Minnesota is authorized by law to collect certain fees; and
- WHEREAS, the Town Board of Watab has adopted Ordinances that require the collection of permit fees; and

Special Meeting Fee:	Meetings requiring action by the Town Board outside the regular monthly meeting, reimbursement must be made by the requestor prior to the meeting to cover the cost of the Board members attending at \$25 per board member.
Emergency Call Fee:	For emergency services, Watab residents will pay 75% of the first hour of the call and 100% of any additional hours incurred. Non-residents of Watab or those not owning property in Watab will pay 100% of the cost for emergency services (does not include resident renters).
Subdivision Fees:	Application Fee: \$400.00 (1-9 lots) Application Fee: \$600.00 (more than 9 lots) (additional \$25 for each lot over 9) Final Plat Fee: \$150.00 Escrow: \$2,500.00
Easement/Utility Vacation Fee:	Application Fee: \$75.00
