RESOLUTION GIVING PRELIMINARY APPROVAL

- A. WHEREAS, the Town Board of the Town of Watab, Minnesota (the "Town") proposes to issue its general obligation street reconstruction plan bonds in one or more series from time to time (the "Bonds") and adopt the Town of Watab, Minnesota Street Reconstruction Plan of 2021 through 2025 for the reconstruction of certain streets in the Town (the "Plan"); and
- B. WHEREAS, the Town has caused notice of the public hearing on the intention to issue the Bonds and on the proposed adoption of the Plan to be published pursuant to and in accordance with Minnesota Statutes, Section 475.58, Subdivision 3b; and
- C. WHEREAS, a public hearing on the intention to issue the Bonds and on the proposed Plan has been held on this date, following published notice of the hearing as required by law; and

NOW, THEREFOR, BE IT RESOLVED by the Town Board of the Town of Watab, Minnesota, that the Town hereby gives preliminary approval for the issuance of up to \$3,500,000 aggregate principal amount of the Bonds. The Plan is hereby adopted, the same being before the

Town Board and made a part of these proceeding intent to reimburse itself for the costs of the Planta and the costs of t	ngs by reference. The Town declares its official an from the proceeds of the Bonds.
